Guidelines

- Maximum of TWO booths per company (priority for second booth given to exhibitors who had two booths in 2019)
- Exhibits must not extend beyond the boundaries of the booth.All exhibitors are required to provide General Liability insurance
- All exhibitors are required to provide General Elability insurance naming ICSC, GES, and Fairmont Whistler Chateau Resort as co-insured to the listed ICSC contact.
- Please adhere to the height restrictions as outlined in the ICSC Display Rules and Regulations (available in the exhibitor dashboard).
- All guidelines are subject to regulations of venue and ICSC.

Availability

- Exhibit space renewals must be completed online and full payment must be received by **June 18, 2019.** Companies that fail to meet this deadline will lose their 2019 priority booth location status. There are no exceptions.
- After **June 19**, all rights of first refusal are revoked, and remaining booth space is offered on a first-come basis. ICSC member companies are given first priority to all booth assignments, as are companies who have reserved guestrooms at the Fairmont Chateau Whistler Resort.
- Applications will not be approved without payment.
 ICSC cannot guarantee that you will not be placed near a competitor.

Directory Deadline
