

# 2021 CLE Information and State Approvals

Please note, approvals and restrictions vary by state, so check the approval chart below to see what your jurisdiction will allow.

All attendees seeking Continuing Legal Education (CLE) credits will receive an email on Tuesday, November 16 with a link to add jurisdiction(s) and bar number(s), confirm sessions and obtain a Certificate of Attendance. You must do this by Friday, November 26 for ICSC to report your credits for you (where applicable). If you do not complete by the deadline and are in jurisdiction(s) where ICSC reports for you, you will need to self-file instead.

Please note: The seven General Sessions will be recorded and offered on-demand for viewing Monday, November 8 – Friday, November 12 for CLE credit. Approvals vary by jurisdiction so please make sure to check the approval chart below. You will receive an email after the conference with directions on how to access these sessions.

## At the Conference

### Let the RFID tags on your badge holders do the work for you!

- RFID Radio Frequency Identification tags track your attendance at the sessions only; nowhere else.
- No tapping, no scanning, just walk through the session door.
