2ND WARD ALDERMAN

2nd Ward Alderman Brian Hopkins was first elected to Chicago's City Council in May 2015 and was re-elected in February 2019. Prior to being elected into office, Hopkins worked in the Cook County Commissioners office, where he served as Chief of Staff to the Finance Committee Chairman John P. Daley, under the tenure of President Toni Preckwinkle. Along with his job at Cook County,

Hopkins was twice voted President of the respected community group, the Streeterville Organization of Active Residents (SOAR). At the helm of SOAR, Hopkins represented the community and solved complex issues to improve the quality of life for local residents. A champion of environmental, sustainability and resiliency initiatives, Hopkins serves on the Lakeshore Planning Committee, a group of civic leaders advocating a bold plan to add more green space and public parkland to Chicago's Lakefront

Today, Alderman Hopkins continues his work to deliver open, green and recreational space for Chicagoans, and fights to protect constituents from health risks associated with environmental contamination at former industrial sites. Representing a diverse ward that includes neighborhoods spanning from Streeterville and the Gold Coast, to Lincoln Park, Bucktown and Ukrainian Village, Alderman Hopkins has shepherded some of Chicago's most important and impactful projects to completion.

In May 2022, per legally mandated process, the City Council passed a new ward map in conjunction with 2020 Census data. Alderman Hopkins supported a more open and independent process for redistricting, sponsored legislation calling for the process to be reformed, and, because it was designed to protect incumbents members of City Council instead of neighborhoods, voted against the gerrymandered map that did ultimately pass. In the new map, due to the addition of nearly 8,000 residents within the current boundaries, the 2 nd Ward loses territory and moves entirely east of the river. Alderman Hopkins will continue to represent all residents of the current 2 nd Ward until May 2023 and looks forward to then serving many of the same residents and new residents alike in Lincoln Park, Old Town, Gold Coast, River North, and Streeterville

LINCOLN YARDS

The 320,000 square foot life sciences building, which features 280,000 square feet of much needed medical research labs and creative office space, is progressing rapidly. Approvals for future stages of construction in Lincoln Yards South have passed Plan Commission. Progress also continues to be made on the planning of the 606 extension, new bridges over the river, the park, and the next phase of buildings.


741 N. WELLS

741 N. Wells is a 21-story mixed-use building that will contain 178 residential rental units, ground-floor retail tailored to smaller restaurant tenants, and 51 garage parking spaces. A groundbreaking ceremony was held on August 10th, and construction is now well underway.

1120 N. STATE

304 upscale rental apartments are soon to be built at 1120-30 N. State in a 29-story structure that will also contain ground-floor retail and 105 garage parking spaces. Demolition of the existing one and two story retail buildings on the site are expected to take place in October with construction to begin shortly thereafter.





NORTH AUSTIN COMMUNITY CENTER

The \$2 million sale of the city-owned vacant land for the development of the North Austin Community Center was unanimously approved at a Sept. 9 City Council meeting. The project has been in development since 2017 as a partnership between Grace and Peace Church and By the Hand Club for Kids. But the city agreed to the proposal after an outpouring of support from residents in favor of the community center. The community really embraced the project. It fit the needs of folks in the community," The community campus at 1815 N. Laramie Ave. will have extensive programming aimed at young people, especially those 16-25 years old, to find a "sense of direction and purpose.

PEACHES AND CULVERS

Mayor Lori Lightfoot moved to acquire land from the CTA to pave the way tor construction of two Black-owned restaurants adjacent to a police and fire training academy in West Garfield Park. The CTA property at 4331-4359 W. Chicago Ave. was acquired for \$1 0 and was part of plans to have "two AfricanAmerican-owned restaurants, Peach's and Culvers" built on "out lots" adjacent to the 30.4-acre training complex at 4301 W. Chicago. "This is not an expansion of the Joint Public Safety Training Academy site nor is this any new funding towards the site, but rather standing operating procedure as the construction of the two restaurants move forward.



THE TERMINAL- 1334 N.KOSNER

A cluster of old warehouses in West Humboldt Park will soon be transformed into a "creative office campus" for tech companies and makers. A team of development partners are converting three _.. warehouses at 1334 N. Kastner Ave., the longtime home of lighting and electrical equipment manufacturer Pyle-National Co., into a modern office campus called "Humboldt Lit." "Pachucki, president of IBT Group LLC, enlisted the real estate company Cawley Chicago to lease out the office space. Their goal is to lure tech companies or other companies with a creative focus like furniture makers to the area. The site, which spans more than 6.5 acres and offers 250,000 square feet of space, can accommodate "somewhere between one and a lot" of companies




40TH WARD ALDERMAN




42ND WARD ALDERMAN

Alderman Brendan Reilly has served as a member of the Chicago City Council since 2007 when he unseated a 36-year incumbent, who was the second longest serving alderman on the City Council. Alderman Reilly represents downtown's 42nd Ward - Chicago's Central Business District and home to 90,000 residents and over 10,000 business licenses. Alderman Reilly's 42nd Ward represents nearly 60% of the city's economic activity.

WOLF POINT TOWERS

In March of 2013, City Council passed the three-phase development project, designed by Pelli Clarke Pelli. Two of the three skyscrapers, Wolf Point West and Wolf Point East, are complete and serve as luxury apartments. The third and final phase of the Wolf Point master plan is Salesforce Tower Chicago (aka Wolf Point South).



Hines is developing Salesforce Tower Chicago in partnership with the longtime land owner, the Joseph P. Kennedy Family to create the most advanced and amenitized office building in Chicago. Building construction is expected to be completed in 2023 with exterior plaza work finished before winter

THOMPSON CENTER

In May of 2021, Alderman Reilly received City Council approval on an ordinance to rezone the James R. Thompson Center (JRTC) from PD 270 to DC-16. The ordinance was introduced at the request of Governor JB Pritzker as the State of Illinois was seeking to market the property for future sale. In July of 2022, J.B. Pritzker announced the sale of JRTC, located at 100 West Randolph, in the 42nd Ward. The title of the new property will be transferred to JRTC Holdings, LLC, and Google will become the building's new occupant. Google and JRTC Holdings, LLC have entered into a build-to-suit agreement; Google intends to occupy the building upon completion of the renovation. The JRTC renovation is expected to begin later this year following the financial closing, and take approximately two years to complete.



Tom Tunney was born and raised on the South Side of Chicago. He left to pursue his education, obtaining his undergraduate degree in restaurant management from the University of Illinois and a Master's degree in hotel management from Cornell. He returned to Chicago in 1980, settling in the Lakeview neighborhood, which has been his home since. Having taken over the Ann Sather restaurant in 1980, a pivotal moment in the history of gay rights and the developing HIV/AIDS crisis soon followed and Tom was determined to make a difference. One of the first volunteers for the newly founded Open Hand Chicago (a program to provide home delivery of hot meals to patients with AIDS), Tom opened up his restaurant to help with the preparation and distribution of meals. Since that time, he has continued to provide meeting rooms at the restaurant, welcoming a number of different community groups.

In February 2003 Tom became Chicago's first openly gay Alderman. Since then he has worked in a very hands-on manner to put into effect his belief that working in the best and balanced interests of both residents and businesses makes a vibrant and successful community. His commitment to this ethic has won accolades:

- Out Traveler Magazine voted the local Boystown area as, "Best Gay Neighborhood
- In 2013, CNN Money Magazine named Lakeview as the third best big city neighborhood in the USA.

360 N BROADWAY

Optima Lakeview located at 3460 N. Broadway is an eight-story, mixed-use, transit-oriented development. The development consists of 8,880 square feet of commercial space at the first floor with 107 fully-enclosed parking spaces located at the rear of the site. The 2nd through 8th floors contain 246 rental residences ranging from efficiency units to three-bedroom units. The development eliminates three of the four existing curb cuts on Broadway due to the dramatic reduction in traffic from the site's prior use as a grocery store, while adding two new on-street parking spaces and a standing zone located in the parking lane to mitigate any potential disruption of traffic. The project includes a roof deck with a pool and spa, as well as other amenities throughout the building, including a basketball court, a fitness center, game and party rooms, dog park and outdoor plazas and terraces. The development will have on-site property management and a 24/7 concierge.

3115 N BROADWAY

The new owners of 3115 N. Broadway are excited about the possibility to bring class-A multifamily apartments to the neighborhood. As they continue to work with the community group and the Alderman, their plans may change slightly, but their most recent ambitions are outlined in the below documents.

They are pursuing a Planned Development as a TOD to achieve the 50% reduction in parking (60 stalls will be available under current plans).

44TH WARD ALDERMAN

3179 N CLARK

Hubbard Street Group is planning to redevelop the property located at the corner of Clark, Belmont and Halsted (3179 North Clark Street) into a two-story commercial development with underground parking. The property is currently improved with a two-story building occupied by Fifth Third Bank and a surface parking lot. The project will be constructed on the entire footprint of the site and reach a maximum height of approximately 48 feet. The new development will include approximately 59,000 square feet of new retail / commercial space on two floors, including over 20,000 square feet of ground floor space along the approximately 295 feet of continuous retail frontage on Belmont Street. The underground parking level will be accessed off of Clark Street, and loading will be accessed off of Halsted Street. The property is currently zoned B3-3 and B3-2, and the development will be built as-of-right with the existing zoning.
