2023 CLE Information and State Approvals

Please note, approvals and restrictions vary by state, so check the approval chart below to see what your jurisdiction will allow.

All attendees seeking Continuing Legal Education (CLE) credits will receive an email on **Tuesday, November 7, 2023** with a link to add jurisdiction(s) and bar number(s), confirm sessions and obtain a Certificate of Attendance. You must do this by **Friday, November 17, 2023 at 3:00pm EST** for ICSC to report your credits for you (where applicable). If you do not complete by the deadline and are in jurisdiction(s) where ICSC reports for you, you will need to self-file instead.

At the Conference

Let the RFID tags on your badge holders do the work for you!

- RFID – Radio Frequency Identification – tags track your attendance at the sessions only; nowhere else.
- No tapping, no scanning, just walk through the session door.

Post-Conference

Confirm your attendance and retrieve your Certificate of Attendance

- You will receive an email with a link to log in to the CLE system.
- Log in with your last name and email address.
- Confirm your contact information and enter your jurisdiction(s).
- Download your Certificate(s) of Attendance.
