

2025 CLE Information and State Approvals

Please note that approvals and restrictions vary by state, so check the chart below to see what your jurisdiction will allow.

All attendees seeking Continuing Legal Education (CLE) credit will receive an email the morning of **Wednesday**, **October 8**, **2025**, with a link to the CLE Online Platform. Through the CLE Online Platform, attendees can add their jurisdiction(s) and bar number(s), track their sessions in real time, and obtain a Certificate of Attendance. Attendees who wish to have ICSC report CLE credits on their behalf (where applicable) must login to the CLE Online Platform and verify that all their information is correct no later than **Friday**, **October 17**, **2025**, **at 5:00 pm ET**. If you do not login and verify by the deadline and are in any jurisdiction(s) where ICSC reports for you, you will have to self-file instead.

At the Conference

Let the RFID tags on your badge holders do the work for you!

- RFID (Radio Frequency Identification) tags track your attendance at the sessions only nowhere else.
- No tapping, no scanning just walk through the session doors.

- You will receive an email with a link to access the CLE System.
- Login with your name and email address.
- Verify your contact information and enter your jurisdiction(s) and bar number(s).

State Approvals

ICSC has applied to the following state bars for CLE approval of 720 minutes of total live instruction, including 480 minutes of Ethics instruction, 60 minutes of Elimination of Bias/Diversity & Inclusion instruction (select states), 120 minutes of Professionalism instruction (select states), 60 minutes of Substance Abuse/Mental Health/Competency instruction (select states), and 180 minutes of Tech/Cybersecurity instruction (select states). This excludes breaks and networking opportunities.

Calculate Your Credits:

The total credits listed below reflect the maximum number of credits an attendee can earn at the 2025 conference, including the maximum Ethics, Elimination of Bias/Diversity & Inclusion (where applicable), Professionalism (where applicable), Substance Abuse/Mental Health/Competency (where applicable), and Tech/Cybersecurity (where applicable) credits for that jurisdiction. Pending approval, in 60-minute states, every 60-minutes of instruction is equal to 1.0 credit. 
