Roundtables are a great way to meet likeminded peers for informal discussions on a wide range of topics.

**Attend sessions:** Figuring out which sessions to attend can be tricky. Our guide below to the different session types will help you understand what to expect from the session aside from the content.

- I. General Sessions** are intended to provide a broad, general perspective of the topic. Sessions are held in large rooms and led by a panel of three or four speakers. There is limited interaction with the audience as a result of the size and scope of the presentation.
- II. Seminars** are intended to be a more in-depth discussion of the topic. They are led by two or three practitioners with substantial prior experience on the topic. Interaction with the audience is encouraged, but the session speakers are expected to control and limit discussion as well as cover all the subject matter described in the outline of the session.
- III. Workshops** are intended to be interactive and are typically led by two practitioners with a substantial level of experience in the topic area. Interaction between the workshop leaders and the audience is encouraged and expected, with the freedom to stray from the outline and address audience concerns in a more specific and detailed fashion.
- IV. Peer to Peer** sessions involve breakouts into small group discussions with reporting back to the entire workshop. All Peer to Peer workshops are considered to be advanced.
