



ICSC Student Membership Application

STUDENT MEMBER ELIGIBILITY REQUIREMENTS

To be eligible for student membership, a student must be able to provide proof of full-time enrollment at an accredited university or college. Full-time enrollment is defined as undergraduates enrolled in at least 12 credits and graduate students enrolled in at least 6 credits in semester-based academic programs.*

An individual who is a permanent employee or has an outgoing business agreement and holds a title with any firm or brokerage is not eligible for a student membership. Working as a temporary intern or part-time while enrolled in school full-time to complete a degree is acceptable.

In order to apply for a student membership, a student must provide the following documents; students who cannot provide the following documents are not eligible for a student membership at ICSC - **there are no exceptions.**

Required documents are:

- The completed student membership application form, **AND**
- One of the following documents:
 - A transcript or course list showing the courses you are enrolled in for the current or upcoming semester. A transcript in .txt format is **NOT** acceptable; **OR**
 - A letter from your college student affairs or admissions office stating that you are enrolled as a full-time student for the current or upcoming semester. This letter must be on school letterhead, display a school seal or logo and contain a signature and phone number of a representative from the admissions office.

Certification or licensure programs are not eligible for student membership.

Student members with more than 4 years of student membership do not qualify for renewal.

*For those students not in a semester-based program, in addition to the above documents, they may submit a letter on official letterhead from the school administration verifying that they are enrolled full-time to confirm eligibility.

NOTE: ICSC reserves the right to verify all submitted documents. This category is not eligible for automatic renewal. You will need to re-apply and provide documentation of your full-time enrollment each year.
